

## PUBLIC HEARING-INTENT TO FRANCHISE Regular Board Meeting Wednesday July 14, 2021 6:00 PM

The Town of Big Lake Board of Supervisors met in regular session, at 6:00 PM, on Wednesday July 14, 2021 at the Town of Big Lake Town Hall, located in the Big Lake Township's Lions Park Community Center, at 21960 County Road 5 NW, Big Lake Township, Sherburne County, State of Minnesota. The meeting was called to order by Chair Bruce Aubol and the Pledge of Allegiance was recited. Vice-Chair Dean Brenteson, Supervisor Larry Alfords, Supervisor Norm Leslie, Supervisor Mark Hedstrom, Treasurer Kenneth Warneke, Clerk Brenda Kimberly-Maas, Deputy Clerk Jayme Swenson were in attendance.

## Overlay Construction Update

Ken Warneke reported that most of the overlays had been completed. Revised Plat of Eagle Lake Park was done today, Huckleberry Hideaway was yet to be overlaid. Restoration of the right of ways will be completed shortly after the overlays are finished.

# Knick Knack Knoll Temporary Cul-de-sacs & 180th Street Extension

The two temporary cul-de-sacs (183<sup>rd</sup> St and 181<sup>st</sup> St.) have been paved by ASTECH. Clint Corrow has had the draft of the permanent easement agreement for the extension of 180<sup>th</sup> Street to be looked over by his legal counsel, for a few weeks. Staff has reached out to see if there are any concerns from Clint or his counsel. No response has been heard. Supervisor Brenteson will reach out to Clint on the matter.

## **Treasurer's Report**

Treasurer Warneke informed the Board the Town received the first 2021 property tax disbursement (30%), including the settlement from Big Lake Industrial Park. The one-time annual solar settlement was also in this payment. Of note was the negative balance seen in the General Capital fund. This is due to rebates that are made to tax payors. A rebate may occur if a home is lost to a disaster like a fire.

Ken reviewed the Treasurer's Report and Financial Statements with the Board. The town treasury ending balance (less escrows) was \$2,428,631.01 Ken noted that balance is the largest he recalls seeing, but it will be back to a lower amount as soon as the overlay contract invoice is received and paid. *Financial Reports are retained as part of the official Minutes and available in the Clerk's Office*. Motion/Second to approve the Treasurer's report by: Hedstrom/Leslie. Approved by: Aubol, Alfords, Brenteson, Hedstrom and Leslie. None opposed. Motion Prevailed.

### **Business from the Board – Committee Reports/Updates**

Supervisor Leslie informed the Board the park's irrigation was fixed and the grass is finally greening up.

Supervisor Aubol will be attending the County's Planning and Zoning Board of Adjustment meeting where the Gullickson Addition Plat will be reviewed..

Supervisor Brenteson reminded the Board that if they know of a good project manager, the CMRP Joint Powers Board is still looking for one, to help with the 2030 Framework project.

Supervisor Alfords reported he was called out to inspect a report of noxious weeds in one of the developments. He and Mitch Glines, the County weed inspector, investigated the report and found Wild Parsnip, Common Tansy, and Queen Anne's Lace. The right of way affected will not be mown during the growing season and the weeds will be chemically treated in September.

Supervisor Hedstrom congratulated the Board on the award from the Soil & Water Conservation District Board and the removal of Birch Lake from the impaired waters listing.
