

**TOWN OF BIG LAKE
MAILBOX POST INSTALLATION
ORDINANCE No. 1150**

INSTALLATION AND REPLACEMENT OF MAILBOXES AND SUPPORTS

In order to provide for the health and safety of the people of this township and in order to provide delivery of mail, the Board of Supervisors of the Township of Big Lake, Sherburne County, State of Minnesota, do hereby adopt the following ordinance:

1. Any person installing or replacing a mailbox and post shall place such at a vertical height of 42-48 inches above street level to the bottom edge of the mailbox and at a horizontal length of 36 inches from the curb or edge of pavement to the vertical post. The box opening shall be within six-inches (6") from the edge of the pavement.
2. A mailbox installation or support must meet Federal and State regulations for breakaway standards. Mailbox post must meet the design, as depicted in EXHIBIT A.
3. No mailbox shall be placed in a cul-de-sac. Rather mailboxes will be placed before or after the entrance of a cul-de-sac.
4. The installer is responsible for calling for utility locates (Gopher One - call 811) prior to digging or installation of post.
5. Refrain from planting flowers or shrubs, on or around the base of the mailbox post. Do not place newspaper boxes under the mailbox, rather install them along the side the of mailbox.

DATE OF EFFECT

This Ordinance shall be in full force and effect from and on its passage, approval and publication, as provided by law, and simultaneously all other ordinances, or portions of ordinances, in conflict herewith are hereby repealed to the extent of such conflict. **THE FOREGOING ORDINANCE WAS DULY ADOPTED** this 22nd day of September 2021, by the Town of Big Lake Board of Supervisors.

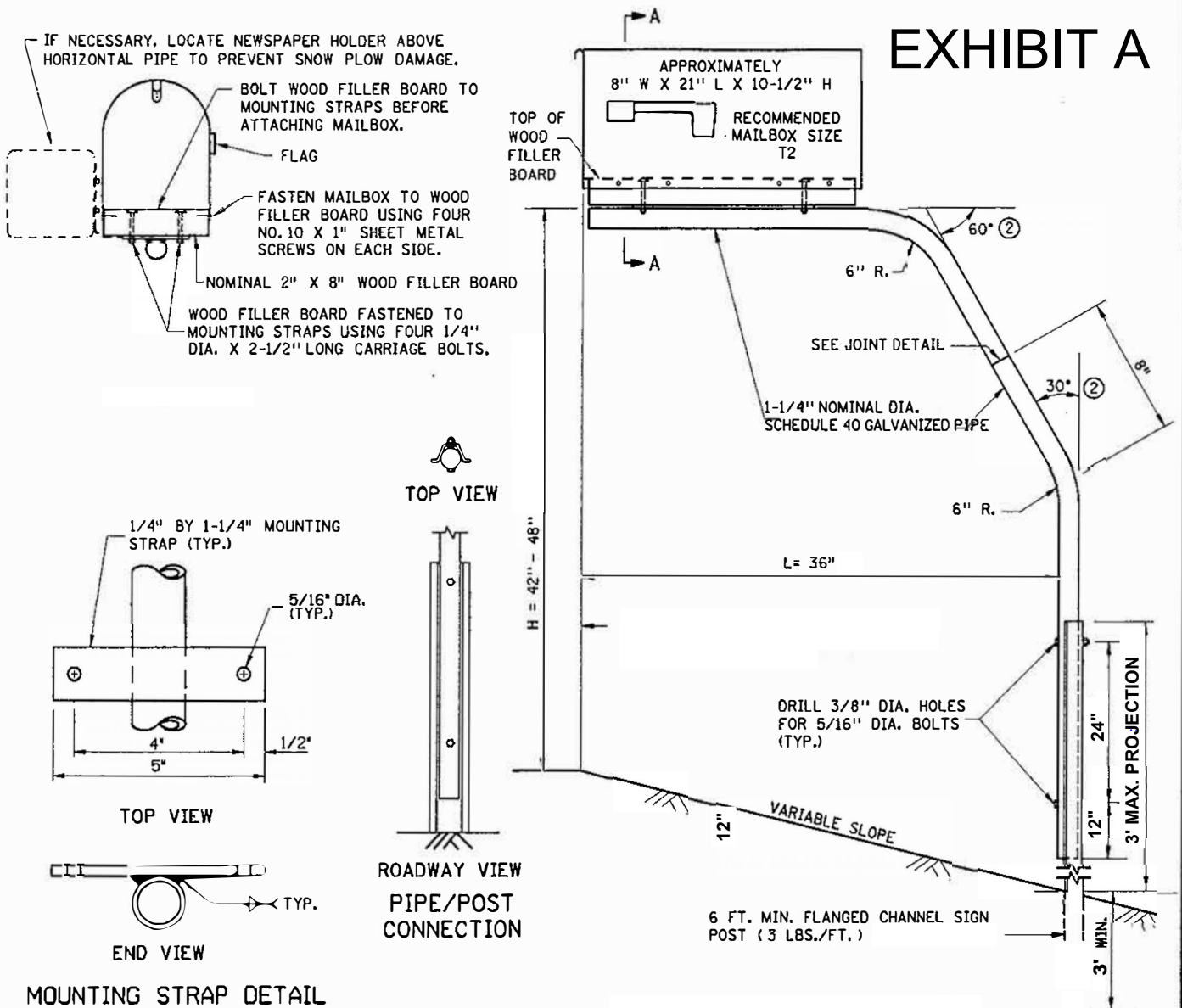
